My Mobile Money Access Coming Soon!



Indiana State University Federal Credit Union will soon introduce a new mobile app called My Mobile Money Access. This app will be in addition to our current CU Go Mobile Account Access app to help you control and monitor debit card usage anywhere, anytime using your mobile phone. With My Mobile Money Access you will be able to protect your debit card from fraud by setting alerts and controls to determine how your debit card can be used. And, if you misplace your debit card, you will be able to use the app to turn it off . . . and then turn it back on when you find it!

You will also be able to use My Mobile Money Access to manage your spending. With customizable controls, alerts for spending limits, and easy-to-find account balances, you can set a budget and stick to it.
